#### AGENDA ITEMS

#### I. <u>Call to Order</u>

The meeting was called to order at 10:00 am. The meeting was recorded.

#### II. Approval of the October 25, 2023 Meeting minutes

Chair Garcia asked for a motion to amend the Notice and Agenda to include the approval of the November 2, 2023 Special Meeting Minutes.

Board Member Matthews **moved** to amend the Notice and Agenda to include the approval of the November 2, 2023 Special Meeting Minutes. Board Member Young **seconded** the motion. Motion **passed** unanimously.

Chair Garcia asked for comments or amendments to the October 25, 2023 Board meeting minutes.

Board Member Young **moved** to approve the October 25, 2023 Board meeting minutes as presented. Board member Matthews **seconded** the motion. Motion **passed** unanimously.

Chair Garcia asked for comments or amendments to the November 2, 2023 Board Special meeting minutes.

Board Member Young **moved** to approve the November 2, 2023 Board Special meeting minutes as presented. Board Member Matthews **seconded** the motion. Motion **passed** unanimously.

#### III. Chair Report (Chair Stephanie Garcia)

There was no Chair Report for discussion.

#### IV. Presentation by Meridian Public Affairs, Legislative Liaisons

Amanda Gall, Legislative Liaison, provided a brief presentation on how things are unfolding with the Legislative Session pertaining to OPG's current needs and how they are monitoring other bills all session and weight-in where the office's interests are implicated.

Chair Garcia informed that the Colorado Cross Disability Coalition is hosting a legislative preview on December 13, 2023, 10:00 am at the Capital with virtual access.

#### V. Director Report (Sophia M. Alvarez)

- a. FY24-25 Budget Request Update
- b. January 1, 2024 Report Update

Director Alvarez's Director Report was distributed electronically along with other materials and discussed. Additional items discussed included, but were not limited to:

Director Alvarez provided the following updates:

- Director Alvarez is meeting with Legislative Liaisons to prepare for the JBC hearing; however, she has not been notified of the hearing date as of this date.
- Director Alvarez informed that Alfredo Kemm, legislative staff, will have a JBC briefing for the independent agencies on 12.05.2023. Director Alvarez informed that she will be attending the briefing.
- Director Alvarez informed that the Legislative Liaisons will be meeting with legislators in the coming weeks.
- Director Alvarez informed that Alfredo Kemm is very supportive of the OPG's budget requests, and he does not expect any objection.
- **A.** Chair Garcia inquired about the hiring of a Staff Attorney.
- Director Alvarez provided the following human resources updates.
  - i. For the 2<sup>nd</sup> JD guardian positions an interview was completed recently and there are three more scheduled for the next two weeks.
  - ii. For the Staff Attorney position four interviews have been completed and there is one more scheduled for next week. Director Alvarez expects to make an offer in December and have the Staff Attorney start in January 2024.

- **A.** Director Alvarez asked the Attorney General's Office if they had an update from the Judicial Department regarding the MOU. Attorney General Finke informed that there are no updates, but he will reach out to the SCAO for updates and will schedule a meeting.
- **B.** Chair Garcia inquired about Director Alvarez attendance to the meetings to the UGCOPAA. Director Alvarez informed that she attended the November 3<sup>rd</sup> meeting and will attend the December 1<sup>st</sup> meeting.
- **C.** Chair Garcia advised that the ARC of Colorado representative Elizabeth Mirand and Bar Association is meeting and looking at the UGCOPAA law through a legal lens. Chair Garcia has requested public access and has not received a response yet.

## VI. <u>Discussion of Appointment of COPG Director by December 31, 2023</u>

Chair Garcia advised that the Board must vote to approve the appointment of the Executive Director by December 31, 2023. Chair Garcia informed that the Board probably needs to start discussing the performance evaluation again for this year. Chair Garcia stated that she will meet with Director Alvarez and get the evaluations forms out for Board Members to provide their feedback.

Attorney General Finke recommended to use same format this year and use the Attorney General's Office to assist with the process. Attorney General Finke informed that this may become a function of ASIA's responsibilities after established.

Chair Garcia asked for a motion to approve the appointment of the Executive Director.

Board member Thiessen **moved** to approve the appointment of the Executive Director. Board member Matthews **seconded** the motion. The motion **passed** unanimously.

#### VII. Public Comment

- **A.** Marcella Schieffelin, member of the public inquired about the following:
  - i. Number of Adults under public guardianship.
  - ii. Where the protected individuals live and who provides services.
  - iii. If there is an initiative with the ARC pertaining to supported decision making and actual need of guardianship.
  - iv. Finding a successor guardian when a parent passes away.
  - v. What happens when parents are divorcing and there is no agreement on legal guardianship of a child who is under 18?

**B.** There was a brief discussion as to the above inquiries and Ms. Schieffelin was asked to contact Director Alvarez directly for further discussion.

#### VIII. <u>Discussion of Critical Incident Reporting</u>

a. Specifically, the matters referred to Executive Session and Discussion of Critical Incident Reporting.

Chair Garcia asked for motion to enter Executive Session to discuss Critical Incidents.

Board Member Thiessen **moved** to initiate Executive Session. Board Member Matthews **seconded** the motion. Motion **passed** unanimously with at least two-thirds of the membership present.

The Board exited open session and entered executive session on a separate line at 10:41 a.m.
