#### I. Budget and Administrative Update.

- a. There is no current monthly budget summary report as the Judicial Budget Analyst priority is the JBC Budget requests.
- b. OPG Board vacancies the Board has one Chief Justice vacancy. Criteria: Attorney, not from the 2<sup>nd</sup> or 7<sup>th</sup> Congressional Districts; not from the Boulder or Arvada Judicial Districts/Localities; from any Party.
  - 1. I confirmed that the attorney that reached out to Chair Fields and me about the vacancy was to apply 10.10.2024.

#### c. FY26 Budget Request.

- 1. I have a meeting scheduled with the new JBC Budget Analyst, Scott Thompson on 10.15.2024.
- 2. The Judicial Budget Manager has not provided me with a final FY Budget document to be submitted to the JBC. It is due on 11.01.2024.
- 3. We requested two Decision Items:
  - a. \$263,392 for 1.0 FTE Grants Specialist, a contracted Community Engagement Coordinator, and a contracted Data Scientist.
  - b. \$184,536 for Participant Enrichment Services.
  - c. I spoke with the new and former JBC Analysts, Scott Thomspon and Alfredo Kemm, on 10.17.2024. They feel that JBC will look favorably upon our requests and that we are acting responsibly with our expansion and state resources and not see this as a delay of expansion.

- 4. I will request a Budget amendment for office space if the final lease numbers are received form the broker in time, by January 2025.
- 5. Amanda Gall spoke with Jarrett Hughes, Deputy Director of Policy and Research, Governor's Office, who will be supporting the OPG and expansion via the Judicial Department's budget increases within the Governor's Budget.

#### d. UGCOPPA.

- 1. Amanda Gall met with Disability Rights Law Colorado Public Policy Liaison, Jack Johnson, who seems open to amendments or not running UGCOPPA at all. Ms. Gall and I have a meeting with Mr. Johnson on 10.31.2024.
- There is mixed messaging on whether the Arc of Colorado or Disability Rights Law Colorado is running the bill and who will be accepting amendments.
- 3. The CBA will be in a neutral position.

#### e. Human Resources Update

- i. New Staff Introductions
  - 1. Katie Donohue 2<sup>nd</sup> JD guardian
  - 2. Michelle Trejo CMHI guardian
- ii. Continue with interviews for one 2<sup>nd</sup> JD guardian position.
- iii. Staffing & Culture Leader position posted on 10.08.2024.
  - 1. Employer's Council HR Manager is handling the recruitment and screening. As of 10.14.2024, we received 37 resumes. The closing date is 10.31.2024.
- iv. I completed Performance Evaluations
- f. Legal Administration SA Murphy continues to assist with day-to-day legal matters, policy review, and mental health motions to intervene, etc.
- g. Former Chair Deb Bennett-Woods, Research Assistant Grant Yoder and I are continuing with publishing our article based on the 2023 Report to the Legislature and met on 10.01.2024. Our next meeting is scheduled for 11.14.2024 where we will have an updated final draft and a final list of publications to submit.

#### h. Attorney General's Office Update

- On 08.20.2024 we received the AG's Office memorandum regarding the office's duties on protecting a client's ALF's residency when drug use is suspected. SA Murphy has reviewed and provided several questions to the AG's Office in response. We are awaiting a Checklist from the AG's Office that has been presented as a tool to assist the guardians and SA Murphy – we received the checklist on 11.15.2024.
- 2. I requested the FY2023-2024 AG Usage Report for request for budgeting purposes. I should receive the Usage Reports ongoing. I received and reviewed the Report and will address some questions with the AG's Office. AG Finke addressed my questions on 06.18.024 and he will make some corrections to the billing. I further addressed some timekeeping and ongoing oversight issues on 08.20.2024 and 10.04.2024. Board orientation on 10.04.2024 was incomplete and Mr. Finke is following up.
- i. Office of Administrative Services for Independent Agencies (ASIA).
  - 1. I met with the Executive Director, Melissa Jamieson, on 10.08.2024. ASIA has scheduled monthly Board meetings and she is updating the Board every other week. The ED has had several meetings with SCAO and other agencies as needed. It seems the goal is to set up ASIA as soon as possible as SCAO services are not available.
- j. On 08.30.2024, SA Murphy and I met with Chief Justice Monica Marquez and her Chief Counsel, Andrew Rottman. It was a great opportunity to share about the OPG. I shared all aspects of the OPG, and the Chief Justice inquired about the lack of resources and offered to reach out to the Judicial Department and the Attorney General's Office to assist in collaboration with our office.
  - The Chair and I met with Chief Justice's Chief Counsel, AG Finke, SCAO Steve Vasconcellos, SCAO Acting Deputy HR Director Danielle Becwar on 10.02.2024. Mr. Vasconcellos agreed that SCAO could assist COPG more and Ms. Becwar agreed to meet with me to discuss OPG's need.
  - 2. Janelle Cantu and I met with Ms. Becwar on 10.15.2024 and discussed our HR, Payroll and Benefits needs considering the needs that we are currently receiving through Employer's Council. Ms. Becwar will review with Mr. Vasconcellos and get back to me by 10.18.2024.

- k. 2024 COPG Annual Report to the Legislature.
  - Grant Yoder, Research Assistant, began working on the 2024 COPG Annual Report to the Legislature. We are using the same format as before, with the reporting period of 10.01.2023 – 09.30.2024. We are adding 5 case studies to show how OPG impacted and improved by COPG.

We are waiting on Employer's Council for their final review of the policy.
